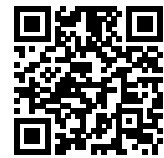

Consent to Recording:

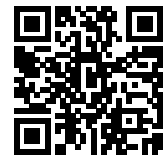
Consultations, emails, calls, texts, and any other forms of communication may be recorded and stored privately for security, legal, and functional purposes of the services.

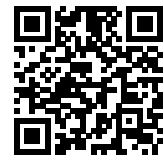
